Re: Transfer Station Stickers and Regulations FY2019

Once again Transfer Station “sticker season” is upon us! Last year’s regulations went well and we had some accountability at the Transfer Station that has shown up in our revenues. I will spell out the details of what the rules and regulations will be for FY2019.

- The Transfer Station Sticker **MUST** be placed on the driver’s side lower corner of the windshield. **ONE STICKER PER VEHICLE**. Each sticker issued will have the Vehicle Registration # written on it for verification purposes.
- **Stickers will remain \$65.00**. Additional vehicles registered to the same household may purchase stickers for \$10.00 each.
- Transfer Station stickers will **ONLY be sold to residents** of the Town of Deerfield, no exceptions will be allowed!
- **Senior Discount** – Residents 65 years or older will receive a FREE roll of Small Bags or a \$17.00 credit towards the purchase of a roll of Large Bags at the time of purchase of the initial transfer station sticker. **Senior MUST be present to receive the discount.**
- Orange Town Trash Bags will continue to be used for trash. **Large Bags: \$25, Small Bags: \$17**
- After July 1, 2018, all residents will be required to have the new 2019 sticker affixed to the windshield of their vehicle. Transfer Station Attendants have been instructed to monitor this closely and non-compliant vehicles **WILL NOT** be able to enter the facility.
- Transfer Station stickers can be purchased at the Deerfield Town Hall Monday thru Friday and for a limited time at the Transfer Station on Saturdays.
- **MUST present your vehicle registration at time of purchase.**
- The facility is equipped with two paper/cardboard compactors; all residents are urged to seek assistance from the facility attendants when utilizing these machines.
- **Getting rid of your vehicle that has the Dump Sticker?** Remove the transfer station sticker from your vehicle before you sell or trade it in. Bring it to the Town Hall office for a replacement at no cost. If the license plate is changing, bring in the NEW vehicle registration too!
- **No replacement for lost stickers.** Additional stickers can be purchased for \$10.00.

These rules and regulations are put in place to provide some accountability to our facility. For several years past, the facility has operated in the red fiscally and was not user friendly to our residents. My job is to change those negatives into positives. Therefore rules, regulations and policies need to be implemented for the facility to operate successfully. Your cooperation and mindfulness will make this facility a pleasant experience for all, thank you.
